Product Description

MAM 100 gsm (50/50) is a laminated absorbent paper interleave manufactured from two plies of food safe virgin pulp tissue bonded using a food-contact approved polyvinyl acetate adhesive. The product is designed to absorb excess moisture and assist in maintaining the quality of fresh produce during storage and transportation.

Intended Use

This product is intended for indirect contact with fresh produce during harvesting, storage and transportation under normal and foreseeable conditions of use. It is not intended for cooking, baking, microwave or oven applications.

Based on our current product formulation, manufacturing process and the information provided by our approved raw material suppliers, Yagdan Manufacturing (Pty) Ltd. t/a Azapak Paper Products declares that, to the best of our knowledge, per- and polyfluoroalkyl substances (PFAS) are not intentionally added during the manufacture of this product.

Additionally, to the best of our knowledge and based on information provided by our approved raw material suppliers, PFAS are not intentionally present in the raw materials used to manufacture this product.

This declaration is based on supplier documentation, formulation knowledge and information available to Azapak Paper Products at the date of issue.

Azapak Paper Products will continue to monitor developments relating to Regulation (EU) 2025/40 and will review and update this Declaration of Conformity and its supporting technical documentation as additional regulatory guidance, supplier information or other relevant information becomes available.

Good Manufacturing Practice

The product is manufactured under documented Good Manufacturing Practices in accordance with Regulation (EC) No. 2023/2006 and within an FSSC 22000 certified Food Safety Management System. Product traceability is maintained throughout the manufacturing process.
