Application

Kraft Punched Coated Bags are designed to provide a protective barrier that preserves the freshness and integrity of grapes during transit, combining the benefits of ventilation (from the punched holes) and an internal coating for moisture resistance. The coating on the inside of the bag creates a moisture barrier that prevents external moisture from affecting the grapes while still allowing airflow to maintain freshness.

Sustainability

The paper component of this product is recyclable where suitable collection, sorting and recycling facilities exist. Actual recyclability is dependent on local recycling infrastructure and the condition of the used product. The product should be disposed of in accordance with applicable local waste management regulations.

Delivery / Packaging

1. Finished product is packed in boxes.
2. Each box contains 1000 units.
3. Boxes are packed at 96 boxes per pallet.
4. Pallets are securely strapped and wrapped to ensure safe transportation.
5. Pallet dimensions: 1000mm x 1200mm.

Storage Conditions

1. Store in a dry, well-ventilated area away from direct sunlight.
2. Ideal storage temperature: 10 – 25°C.
3. Avoid exposure to extreme temperature fluctuations.

Traceability

1. Product description must be clearly labelled.
2. Batch number for full traceability of the product.
3. Production date and batch number (date of manufacture and quantity).
4. All production sheets must record batch numbers for raw materials as per specification.

Additional Notes:

This specification is intended as a general guide only. Full trials and testing should be carried out to verify the suitability of Azapak's bags for specific food packaging applications.
